

## **ISRAEL TRIP CANCELLATION AND REFUND POLICY**

**BY BOOKING ONE OR MORE SEATS ON ALL ISRAEL TRIPS THE FOLLOWING POLICY APPLIES:**

**ALL FUNDS PAID, WITH THE EXCEPTION OF TIPS, ARE PAID WITH THE FULL UNDERSTANDING THAT REGARDLESS OF THE AMOUNT OF NOTICE GIVEN OR REASON FOR CANCELLATION ALL FUNDS PAID TOWARD THE TOTAL COST UP TO AND INCLUDING THE FULL AMOUNT OF THE TRIP ARE NON-REFUNDABLE TO THE TRAVELER OR TRAVELERS. ALL TRAVELERS ARE ENCOURAGED TO OBTAIN TRAVEL INSURANCE IMMEDIATELY UPON MAKING A DEPOSIT AND THE LEVEL OF COVERAGE OR PLAN IS THE SOLE RESPONSIBILITY OF THE TRAVELER. SHOULD YOU NEED TO FILE A CLAIM, EVERY EFFORT WILL BE MADE TO PROVIDE YOU WITH SUPPORTING DOCUMENTATION IN THE FORM OF A LETTER STATING THE AMOUNT YOU HAVE PAID AND THE DATE OF YOUR NOTIFICATION OF CANCELLATION AND THAT ALL FUNDS PAID ARE NON-REFUNDABLE.**

**NO REFUNDS OF ANY KIND FOR AIR, BUS, LAND TRANSPORTATION, NOR HOTELS WILL BE ISSUED FOR ANY REASON AND YOU STATE AND CERTIFY THAT YOU FULLY UNDERSTAND THIS POLICY AND AGREE TO ITS TERMS AND YOU HOLD HARMLESS AND WITHOUT RECOURSE ERIC E. WALKER, INDIVIDUALLY AND IGNITING A NATION, INC. FOR ANY AND ALL LOSSES THAT MAY BE INCURRED ON YOUR PART REGARDLESS OF WHETHER A REFUND CAN BE OBTAINED BY ERIC E. WALKER OR IGNITING A NATION, INC. OR IF YOUR CLAIM THROUGH YOUR TRAVEL INSURANCE CARRIER IS DENIED.**

IN ADDITION, THE ADMINISTRATIVE COSTS OF ORGANIZING, COORDINATING, AND MANAGING THESE TRIPS ARE ALL COSTS INCURRED BY US THAT CANNOT BE RECOVERED.. ALL RESERVATIONS MADE WHETHER BY AIR, BUS, LAND, AND ALL HOTEL RESERVATIONS ARE MADE IN THE NAME OF ERIC E. WALKER AND/OR IGNITING A NATION, INC. AND ARE THROUGH THE GROUP TRAVEL DIVISIONS OF ALL SERVICE PROVIDERS AND, REGARDLESS OF THE SERVICE PROVIDED, YOU ACKNOWLEDGE THAT YOUR TRAVEL CONTRACT IS WITH ERIC E. WALKER AND /OR IGNITING A NATION, INC. AND NOT DIRECTLY WITH ANY ENTITY WHETHER BY AIR, BUS, LAND OR HOTEL. BY YOUR REGISTRATION YOU ACKNOWLEDGE THAT THESE TERMS SUPERSEDE ALL INDIVIDUAL SERVICE PROVIDER'S POLICIES CONTRACTED BY ERIC E. WALKER AND/OR IGNITING A NATION, INC.**

**IT IS FURTHER AGREED THAT ERIC E. WALKER AND /OR IGNITING A NATION, INC. PROVIDE A BUNDLED PRICE FOR THE ENTIRE TRIP AND ARE NOT REQUIRED TO DISCLOSE THE ITEMIZED COSTS OF EACH OF THE COMPONENT PARTS OF THE COST OF THE TRIP. IT IS FURTHER AGREED THAT NO TRAVEL OUTSIDE THE GROUP IS PERMITTED WITH THE EXCEPTION OF THE COST OF TRAVEL FROM YOUR POINT OF ORIGIN TO EITHER BIRMINGHAM OR ATLANTA. ALL PRICING IS ALL INCLUSIVE FROM BIRMINGHAM OR ATLANTA AND NO SERVICES ARE OFFERED FOR TRAVEL TO OR FROM ANY OTHER POINT OF ORIGIN. ALL COSTS INCURRED TO MEET THE GROUP IN BIRMINGHAM OR ATLANTA ARE SOLELY THE RESPONSIBILITY OF THE TRAVELER AND ARE IN ADDITION TO ALL RATES QUOTED IN OUR PRICING. ANY COSTS INCURRED FOR**

**FAILURE TO ARRIVE IN TIME TO TRAVEL WITH THE GROUP SHALL BE THE SOLE RESPONSIBILITY OF THE TRAVELER AND ANY COSTS ASSOCIATED WITH MEETING THE GROUP AT ANY OF THE DESTINATIONS ON THE ITINERARY ARE AT THE SOLE EXPENSE OF THE TRAVELER. ERIC E. WALKER AND IGNITING A NATION SHALL NOT BE HELD RESPONSIBLE FOR ANY COSTS INCURRED FOR FLIGHT DELAYS OR CANCELLATIONS ON THE PART OF THE TRAVELER ASSOCIATED WITH LATE ARRIVALS AT EITHER BIRMINGHAM AND/OR ATLANTA. **IT IS FURTHER ACKNOWLEDGED AND AGREED THAT ALL GROUP AIR TRAVEL IS NON-UPGRADEABLE AND NO POINTS OR FREQUENT FLIER MILES APPLY TO THESE FLIGHTS. SHOULD YOU CHOOSE TO BOOK YOUR OWN FLIGHTS OUTSIDE THE GROUP USING MILES OR FOR UPGRADES YOU AGREE TO HOLD ERIC E. WALKER AND/OR IGNITING A NATION, INC. HARMLESS FOR ANY DELAYS AND ADDED EXPENSES INCURRED FOR ANY AIR TRAVEL BOOKED OUTSIDE THE GROUP AND TAKE SOLE PERSONAL RESPONSIBILITY FOR SAID TRAVEL.
